Questa Foundation for Education administers the following loan and scholarship programs:

During fiscal year 2019, Questa Foundation provided over \$1,483,558 in Questa Scholars loans to 329 students from Adams, Allen, DeKalb, Huntington, Kosciusko, LaGrange, Noble, Steuben, Wabash, Wells and Whitley counties attending college. Students in the Questa Scholars Program are eligible to borrow up to \$20,000 over four years (\$2,500 per semester for up to \$5,000 per academic year) for college. Students who graduate college with a 2.75 cumulative GPA and meet certain residency and employment requirements in northeast Indiana for up to five years after college become eligible to have 50% of the principal loan balance forgiven over the five years. Questa Foundation for Education administers the following grant and scholarship programs:

The Venette and Mabel Sites Grant assists current students with financial need who graduated from public Allen County high schools who are in the Questa Scholars Program. Grants are applied to a student's current Questa loan balance and assist with paying down a student's debt. Awards are made based upon academic performance and financial need. Seventy-five (75) students received \$113,000 in Sites scholarship awards during the fiscal year.
